WHEREAS, Typhoon Lando has devastated many areas in Cagayan Valley and other parts of Northern Luzon from October 18-19, 2015;

WHEREAS, continuous heavy rains caused storm surge and flooding in low areas;

WHEREAS, heavy rains and the release of water from Magat Dam have caused flooding in low areas in Tuguegarao City which damaged agricultural crops and affected many households;

WHEREAS, the City Agriculturist and the City Social Welfare and Development Officer have submitted their reports on the extent of damage on agricultural crops and number of affected households.

NOW THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to declare a state of calamity in Tuguegarao City due to Typhoon Lando.



WHEREAS, a new Rehabilitation Plan will be made and the old one will be scrapped.




