CITY RESOLUTION NO. 150-2015

**A RESOLUTION REQUESTING THE COMMISSION ON ELECTIONS
FOR THE EXTENSION OF VOTER'S REGISTRATION FOR A PERIOD OF
SEVEN (7) DAYS IN TUGUEGARAO CITY**

WHEREAS, Tuguegarao City has been devastated by typhoon Lando causing the cancellation of classes and office work;

WHEREAS, typhoon Lando has caused several roads in the city to be closed due to flooding as a result of the release of water by Magat Dam;

WHEREAS, the devastating effects of typhoon Lando prompted the Sixth City Council to pass *City Resolution No. 149-2015 "Resolution Declaring a State of Calamity in Tuguegarao City due to typhoon Lando"* hereto attached;

WHEREAS, due to the said typhoon, a substantial number of voters in Tuguegarao have not yet registered in the Commission on Elections (COMELEC) Tuguegarao City Office;

WHEREAS, with their number, COMELEC Tuguegarao City Office might not be able to accommodate all these voter registrants within the remaining period of October;

WHEREAS, the Local Chief Executive, Hon. Atty. Jefferson P. Soriano, requested for a seven (7) day extension for the voter's registration.

NOW, THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to request the Commission on Elections en banc through COMELEC R02 Regional Director, Atty. Ederlino U. Tabilas, for the extension of voter's registration for a period of seven (7) days.


RESOLVED FURTHER, to furnish a copy of this Resolution to the City Mayor, Hon. Atty. Jefferson P. Soriano, for information.
