OF THE TUGUEGARAO CITY 2012 EXCISE TAX UTILIZATION”**

WHEREAS, Tuguegarao City is granted a share in the amount of P10,029,060.00, a share on the collection of Burley and Native Tobacco Excise Tax for CY 2012 pursuant to R.A. No. 8240 as amended;

WHEREAS, the Tuguegarao City Development Council has passed CDC Resolution No. 15-2015, endorsing the Excise Tax Utilization for CY 2012;

WHEREAS, the said CDC Resolution enumerates the different programs and projects to be undertaken which shall be funded from the share of Tuguegarao City in the collection of Burley and Native Tobacco Excise Tax for CY 2012;

WHEREAS, the Department of Budget and Management (DBM) issued Local Budget Memorandum (LBM) No. 071 dated September 21, 2015 prescribing the guidelines and procedures in the release and utilization of the share chargeable against the FY 2014 General Appropriations Act (GAA), R.A. 10633, Continuing Appropriations;



WHEREAS, item 3.2 of the DBM Circular requires that the release of funds shall be subject to the submission of the following documents to the DBM Regional Office:

- a. Approved Sanggunian Ordinance or Resolution;
- b. Mechanism and period of implementation; and,
- c. Projected and estimated number of beneficiaries.

NOW, THEREFORE, for and in consideration of the foregoing premises, **RESOLVED**, that CDC Resolution No. 15-2015 endorsing the approval of CY 2012 Excise Tax Utilization granted to Tuguegarao City as its share from the CY 2012 collection of Burley and Native Tobacco Excise Tax in the amount of P10,029,060.00 be approved.


RESOLVED FURTHER, that the list of programs and projects to be implemented with the use of the said Trust Fund shall be supported by corresponding programs of work in accordance with R.A. 7171, R.A. 8290, R.A. 8240 and DBM LBM No. 071, subject to the usual accounting and auditing rules and regulations.

RESOLVED FINALLY, that copies of this resolution be furnished to the Office of the City Mayor, Hon. Atty. Jefferson P. Soriano, Office of the Regional Director of the DBM-RO2, Ms. Isabel C. Taguinod, Director IV, and Office of the Hon. Governor Alvaro T. Antonio of the Province of Cagayan for their information and guidance.
