WHEREAS, the rapid urbanization of Tuguegarao City necessitates the adaptive establishment of sufficient and effective educational facilities to accommodate the growing population of the city;

WHEREAS, considering the fast growing number of elementary education enrollees in Libag Sur, it is compelling upon the Local Government of Tuguegarao City to establish a separate or an annex Public Elementary School that is convenient and is within their reach;

WHEREAS, the realization of the establishment of a separate or an annex public elementary school will decongest the present schools and will definitely improve the service of quality education;

WHEREAS, the establishment of the said school will develop the barangay and will provide convenience and safety to the pupils keeping them away from the hazards of travelling along the national highway and at the same will reduce expenses on the part of the parents, thus making education more accessible and conducive to pupils;

WHEREAS, the establishment of this proposed Public Elementary School will help the full implementation of the “K-12 Basic Education Program/Curriculum” under RA No. 10533, otherwise known as the “Enhanced Basic Education Act of 2013”;

WHEREAS, the Department of Education as the main arm of the national government to govern the Philippine system of basic education has the responsibility of maintaining and providing appropriate measures for the development and advancement of the same.

WHEREFORE, be it **RESOLVED**, to request the Department of Education Regional Office No. 02 (DepEd RO2) through its Regional Director, Dr. Lorna Dig Dino, to establish a separate or an annex elementary school at Barangay Lingaling, Libag Sur, Tuguegarao City to consider this resolution in their budgetary allotment for appropriate funding.


