RESOLUTION APPROVING THE MEMORNADUM OF AGREEMENT AND GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR, ATTY. JEFFERSON P. SORIANO, TO ENTER, SIGN AND EXECUTE THE MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF CAGAYAN TO FACILITATE THE RELEASE OF THE FUND ASSISTANCE IN THE AMOUNT OF P1,000,000.00 UNDER THE LGU ASSISTANCE PROGRAM FOR THE IMPLEMENTATION OF THE LANDFILL DEVELOPMENT PROJECT

WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991, specifically under Section 33 provides that local government units may undertake cooperative undertakings for their common benefit;

WHEREAS, the Provincial Government of Cagayan sees the importance of such joint undertaking for effective local governance and in promoting general welfare;

WHEREAS, the Provincial Government of Cagayan is extending financial assistance to Tuguegarao City Government for the Landfill Development Project located at Barangay Carig Norte, Tuguegarao City.

NOW, THEREFORE, be it **RESOLVED**, to approve the Memorandum of Agreement and to grant authority to the Honorable City Mayor, Atty. Jefferson P. Soriano, to enter, sign and execute for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Provincial Government of Cagayan to facilitate the release of the fund assistance in the amount of P1,000,000.00 under the LGU Financial Assistance Program for the implementation of the Sanitary Landfill Development Project.




