**CITY RESOLUTION NO. 175-2015**

**RESOLUTION APPROVING CAFC RESOLUTION NO. 005-2015 – “RESOLUTION REQUESTING FREE TRACTOR SERVICES TO TYPHOON “LANDO” AND FLASH FLOOD AFFECTED FARMERS WITH FARM LOCATION WITHIN THE CITY” AND GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR, ATTY. JEFFERSON P. SORIANO, TO GRANT TAX RELIEF TO FARMERS AFFECTED BY TYPHOON “LANDO” AND FLASH FLOOD**

**WHEREAS**, the City Agricultural and Fisheries Council (CAFC) passed CAFC Resolution No. 005-2015 – “*Resolution Requesting Free Tractor Services to Typhoon “Lando” and Flash Flood Affected Farmers with Farm Location Within the City*”;

**WHEREAS**, in said CAFC Resolution, the Council has requested for free tractor services to all affected farmers whose farm locations are within Tuguegarao City with a maximum area of one (1.0) hectare per farmer for the current cropping season only which is from October 2015 to January 2016 (dry Season);

**WHEREAS**, there were farmers who already paid the tractor service fee but were not able to avail of the tractor service with fee due to the calamity, hence, they also request that these farmers who already paid can only apply once their previous payment for the next cropping season (April 2016 Wet Season);

**WHEREAS**, the request is in the form of a tax relief through the liberal application of City Ordinance No. 07-2011 – “*An Ordinance Enacting the Revenue Code of Tuguegarao City*”;

**WHEREAS**, to grant such tax reliefs, Tuguegarao City Government through the City Mayor shall be authorized to temporarily lift the provisions of City Ordinance No. 07-2011 pertaining to the rental of machineries and equipment owned by the City Government.

**NOW THEREFORE**, for and in consideration of the foregoing premises, **RESOLVE**, as it is hereby **RESOLVED**, to adopt and approve CAFC Resolution No. 005-2015 and to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to grant tax relief to affected farmers and farm owners by temporarily lifting the application of the provisions of City Ordinance No. 07-2011 on the rental of machineries and equipment owned by the City Government only on this current cropping season which is from October 2015 to January 2016 Dry Season.

**RESOLVED FURTHER**, to forward a copy of this Resolution to the Local Chief Executive, Hon. Atty. Jefferson P. Soriano, for appropriate action.
