RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE TUGUEGARAO CITY GOVERNMENT WITH THE PROVINCIAL GOVERNMENT OF CAGAYAN REPRESENTED BY THE PROVINCIAL GOVERNOR, HON. ATTY. ALVARO T. ANTONIO FOR THE GRANT OF FINANCIAL ASSISTANCE IN THE AMOUNT OF FIVE MILLION PESOS (P5,000,000.00) FOR THE INSTALLATION OF STREETLIGHTS ALONG ENRILE BOULEVARD, CARIG SUR, TUGUEGARAO CITY

WHEREAS, Tuguegarao City Government acknowledges the importance of joint undertaking for effective local governance and in promoting the general welfare through the implementation of programs, projects and activities with the Provincial Government of Cagayan;

WHEREAS, the Provincial Government of Cagayan is aware of the limited financial capability of Tuguegarao City of implementing various programs and projects in the city, hence, will extend financial assistance to the latter for its projects;

WHEREAS, the Tuguegarao City Government accepts the financial assistance to be extended by the Provincial Government of Cagayan for the implementation of project, particularly the installation of streetlights along Enrile Boulevard, Carig Sur, Tuguegarao City;

NOW THEREFORE, for and in consideration of the foregoing premises,


RESOLVED, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to enter into a Memorandum of Agreement with the Provincial Government of Cagayan through the Provincial Governor, Hon. Atty. Alvaro T. Antonio, for financial assistance in the amount of Five Million Pesos (P5,000,000.00) for the installation of streetlights along Enrile Boulevard, Carig Sur, Tuguegarao City.
