CITY RESOLUTION NO. 181-2015

RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT WITH FORTY NINE (49) COMPONENT BARANGAYS OF TUGUEGARAO CITY FOR THE GRANT OF FINANCIAL ASSISTANCE FOR THE IMPLEMENTATION OF PROGRAMS, PROJECTS AND ACTIVITIES

WHEREAS, the Tuguegarao City Government recognizes the capability of the barangays as a small autonomous governmental unit to implement the developmental projects within their territorial jurisdiction in the promotion of general welfare of their constituents;

WHEREAS, Tuguegarao City Government is aware of the limited financial and other sources of the barangays in the realization of their desired Programs, Projects and Activities (PPAs) for their constituents;

WHEREAS, Tuguegarao City Government, in its desire to help the objective of the barangays in uplifting the welfare of the constituents and in the promotion of general welfare by providing the needed assistance and services, Tuguegarao City Government is willing and amenable to extend financial assistance to the barangays under the following conditions:

- a. The PPAs covered by the Memorandum of Agreement shall be supported with duly approved corresponding Program of Work;
- b. A barangay resolution for the request of financial assistance and cooperation of joint undertaking or venture in the implementation of developmental PPAs within their barangay;
- c. That the recipient barangay shall liquidate the assistance given to them within a period of thirty (30) days upon completion of the PPAs;
- d. That the use of and disbursement of the funds shall be subject to the usual accounting and auditing guidelines; and,
- e. That any unused funds shall be returned to the City Government.

NOW THEREFORE, for and in consideration of the foregoing premises,

RESOLVE, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to enter into a Memorandum of Agreement with recipient barangays regarding the financial assistance to be extended for the implementation of Programs, projects and Activities (PPAs) within the barangay.


On motion of Hon. Noel A. Mora, with the abstention of Hon. Ronald S. Ortiz, and without any objection from the Body, **CITY RESOLUTION NO. 181-2015** was **APPROVED** under suspended rules.
