CITY RESOLUTION NO. 182-2015

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT AND AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN AND EXECUTE FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND AMONG THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) REGARDING THE IMPLEMENTATION OF SPECIAL LOCAL ROAD FUND UNDER REPUBLIC ACT 8794

WHEREAS, pursuant to Republic Act No. 8794, otherwise known as the Motor Vehicles User's Charge Law, under Section 1, provides that "it is the policy of the state to provide for and ensure the adequate maintenance of national and provincial roads through sufficient funding for the purpose";

WHEREAS, Section 7 of RA 8794 also provides that, "5% of all monies collected shall be deposited in the National Treasury under the Special Local Road Fund which shall be apportioned to provincial and city government in accordance with the vehicle population and size of the road network under their respective jurisdiction and shall be used exclusively for the maintenance of roads, traffic management and road safety devices and for air pollution control;

WHEREAS, pursuant to Section 3 and Section 5 of the Executive Order No. 124, dated January 1987, the Department of Public Works and Highways (DPWH) shall assist the LGUs in developing the latter's capabilities by allowing them greater participation in the local maintenance and safety provisions;

WHEREAS, the Department of the Interior and Local Government (DILG) is an agency mandated to exercise general supervision over the local government units (LGUs) and is tasked to strengthen the capability of the LGUs in the delivery of developed services including the maintenance and construction of local roads and to coordinate the activities undertaken by the LGUs;

WHEREAS, the fund shall be implemented by Tuguegarao City Government by contract based on the Program of Work prepared by the City Engineering Office and approved by the DPWH;


WHEREAS, it is necessary that a Memorandum of Agreement should be entered into for the purpose of delineating responsibilities over the implementation of policies, standards and procedures at the LGU level in accordance with the pertinent provisions of SLRF under the MVUC Law and its Implementing Rules and Regulations.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to authorize the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign and execute for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Public Works and Highways, Regional Office No. 02 and the Department of the Interior and Local Government regarding the implementation of the Special Local Road Fund (SLRF).


On motion of Hon. Noel A. Mora and without any objection from the Body, **CITY RESOLUTION NO. 182-2015** was **UNANIMOUSLY APPROVED** under suspended rules.
