CITY RESOLUTION NO. 184-2015

A RESOLUTION AMENDING CITY RESOLUTION 177-2015 GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE TUGUEGARAO CITY GOVERNMENT WITH THE PROVINCIAL GOVERNMENT OF CAGAYAN REPRESENTED BY THE PROVINCIAL GOVERNOR, HON. ALVARO T. ANTONIO, FOR THE GRANT OF FINANCIAL ASSISTANCE IN THE AMOUNT OF SIX MILLION PESOS (6,000,000.00) INSTEAD OF FIVE MILLION PESOS (5,000,000.00)

WHEREAS, the Sixth City Council approved during the December 1, 2015 Regular Session, City Resolution 177-2015 granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to enter into a Memorandum of Agreement for and in Behalf of the Tuguegarao City Government with the Provincial Government of Cagayan Represented by the Provincial Government of Cagayan represented by the Provincial Governor, Hon. Alvaro T. Antonio, for the grant of Financial Assistance in the amount of Five Million Pesos (5,000,000.00);

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested in his letter dated December 7, 2015 that City Resolution 177-2015 be amended, that instead of the amount of Five Million Pesos (5,000,000.00), it shall be Six Million Pesos (6,000,000.00);

WHEREAS, the Sixth City Council approved the said amendment during the December 11, 2015 Special Session.

NOW THEREFORE, for and in consideration of the foregoing premises,

RESOLVED, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to enter into a Memorandum of Agreement for and in Behalf of the Tuguegarao City Government with the Provincial Government of Cagayan Represented by the Provincial Government of Cagayan represented by the Provincial Governor, Hon. Alvaro T. Antonio, for the grant of Financial


Assistance in the amount of Six Million Pesos (6,000,000.00) instead of Five Million Pesos (5,000,000.00).
