RESOLUTION APPROVING THE MEMORANDUM OF UNDERSTANDING AND AUTHORIZING THE HONORABLE CITY MAYOR, ATTY. JEFFERSON P. SORIANO, TO SIGN AND EXECUTE FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF UNDERSTANDING WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND UPMO-FLOOD CONTROL MANAGEMENT CLUSTER THROUGH ITS PROJECT MANAGER FOR THE CREATION OF RESETTLEMENT COMMITTEE IN THE UNDERTAKING OF FLOOD RISK MANAGEMENT PROJECT-CAGAYAN RIVER COMPONENT

WHEREAS, the National Government through the Department of Public Works and Highways (DPWH) UPMO-Flood Control Management Cluster and with financial support from FRIMP will undertake the construction of the Flood Risk Management Project-Cagayan River Component;

WHEREAS, the overall objective of the Government of the Philippines is to achieve effective management of and financing of flood control projects and the preservation of the same to sustainable operating conditions;

WHEREAS, as a way of ensuring the success of the various development programs of the government, all concerned public and private organizations and institutions must strive to work closely together in policy and program formulation and implementation;

WHEREAS, under the Memorandum of Understanding, Tuguegarao City Government shall be a member of the Resettlement Implementation Committee (RIC) and is tasked among others to assist the project implementors, to monitor the implementation of the project and most importantly, to protect and ensure the compensation and rehabilitation of project affected families;

NOW THEREFORE, for and in consideration of the foregoing premises,




