WHEREAS, the upgrading of the slaughterhouse is in the Annual Investment Program CY 2016 of Tuguegarao City duly endorsed by the City Development Council through CDC Resolution No. 16-2015 – “Resolution Endorsing to the 6th Tuguegarao City Council the Approval of the Tuguegarao City CY 2016 Annual Investment Program”;
