

**CITY ORDINANCE NO. 04-2016**

**AN ORDINANCE CREATING ADDITIONAL POSITION FOR THE CITY TREASURER'S  
OFFICE OF TUGUEGARAO CITY AND PROVIDING FUNDS THEREOF**

**WHEREAS**, Section 458 (I) (viii) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Panlungsod has the power to determine the positions and corresponding compensation and benefits of officials and employees;

**WHEREAS**, in the exigency of service, in order to promote efficiency and institute an effective workforce, there is a need to create an additional position and provide funds thereof for the City Treasurer's Office of Tuguegarao City.

**NOW, THEREFORE**, be it **ORDAINED** by the Sixth City Council in session assembled to enact:

**SECTION 1. TITLE.** This Ordinance shall be known as the "*Ordinance Creating Additional Position for the City Treasurer's Office of Tuguegarao City and Providing Funds Thereof.*"

**SECTION 2.** Additional position for the City Treasurer's Office of Tuguegarao City is hereby authorized and created

**SECTION 3. FUNDING FOR THE NEW POSITION.** The corresponding funds for the salary and benefits for the aforementioned position shall be provided in the Annual Budget and Supplemental Budget of Tuguegarao City.

**SECTION 4.** The filling up of these new position shall be subject to the Personal Services Limitation (PS Limitation, provision of Section 325 (a) RA 7160 or the Local Government Code of 1991 and other Civil Service and DBM guidelines.


**SECTION 5. SEPARABILITY CLAUSE.** If any part of this Ordinance is declared invalid or unlawful by law or issuances, the other parts not affected thereby shall remain in full force and effect.

**SECTION 6. EFFECTIVITY.** This Ordinance shall take effect upon its approval.
