

WHEREAS, the Annual Budget of Tuguegarao City, Cagayan for CY 2015 has provided funds for Intelligence Expenses under the MOOE of the Office of the City Mayor;

WHEREAS, Commission on Audit (COA), Department of Budget and Management (DBM), Department of the Interior and Local Government (DILG), Governance Commission for GOCCs (GCGOCC) and Department of National Defense (DND) Joint Circular No. 2015-1 has provided, Re: Guidelines on the entitlement, release, use, reporting and audit of confidential fund and/or intelligence fund;

WHEREAS, there is a need to amend the account title of the item under MOOE of the Office of the City Mayor indicated as Intelligence Expenses to Confidential Expenses in order to be consistent with the above-mentioned joint circular.

NOW THEREFORE, be it **ORDAINED** in session assembled of the Seventh City Council to enact the following ordinance:

SECTION 1. The account title of "Intelligence Expenses" indicated in Section 3 (1) (1.2) of the Appropriation Ordinance No. 04-2015, authorizing the Annual Budget of Tuguegarao City for Calendar Year 2016, is hereby replaced by the account title "Confidential Expenses" which shall be read as follows:

Section 3. Use of Funds

1. Mayor's Office

1.2 Maintenance and Other Operations Expenses (MOOE)

Confidential Expenses – P5,000,000.00

SECTION 2. SEPARABILITY CLAUSE. If, for any reason, any section or provision of this Appropriation Ordinance is disallowed in Budget Review or declared invalid by proper authorities, other Sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.

SECTION 3. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon approval.

On motion of Hon. Darilo L. Baccay, duly seconded by Hon. Raymund P. Guzman and without any objection, **CITY ORDINANCE NO. 06-2016** was **UNANIMOUSLY APPROVED** under suspended rules.
