CITY ORDINANCE NO. 07-2016

**CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE FROM
VEHICULAR TRAFFIC OF PORTIONS OF GONZAGA, DEL ROSARIO, GOMEZ
AND BONIFACIO STREETS FROM JULY 30, 2016 TO SEPTEMBER 17, 2016
FOR THE TRADITIONAL "PRESYO AGAWID"/FLEA MARKET AND
ACTIVITIES IN CONNECTION WITH THE FIESTA CELEBRATION**

WHEREAS, pursuant to the pertinent provisions of Section 21 (a) (c) and (d) of Republic Act 7160, otherwise known as the Local Government Code, the Local Government Unit of Tuguegarao is authorized to temporary close some of the local roads falling within its jurisdiction for the said purpose;

WHEREAS, the annual celebration of Tuguegarao City's Annual Fiesta has been scheduled on August 08-16, 2016 with a week-long socioeconomic-cultural festivities;

WHEREAS, among the entrepreneurial activities highlighting the traditional fiesta is the conduct of the "Presyo Agawid"/Flea Market;

WHEREAS, the usual venue for the "Presyo Agawid"/Flea Market are the streets around the Central Market, namely: Gonzaga, Del Rosario and Gomez Streets;

WHEREAS, certain activities shall also be held which shall require closure of Bonifacio Street on August 8 to 12, 2016, 6:00-9:00 A.M. and 12:00 NN to 3:00 P.M. and August 13, 2016, 5:00 A.M. to 2:00 P.M.;

WHEREAS, the closure of portions of Gonzaga, Del Rosario and Gomez Streets shall commence on July 30, 2016 to enable the installation and putting up of stalls for the "Presyo Agawid"/Flea Market from July 30 to 31, 2016 and shall end on September 17 for the dismantling of tents from September 16 to 17, 2016;

WHEREAS, a comprehensive and integrated plan on transfer and relocation, traffic management, safety and security, and health and sanitation including the site plan and layout for the conduct of the "Presyo Agawid"/Flea Market 2016 was submitted;

WHEREAS, there is a necessity of withholding from vehicular traffic the said streets for purposes of the "Presyo Agawid"/Flea Market and activities in connection with the fiesta celebration for the entire period of July 30, 2016 to September 17, 2016 in accordance with the provisions of Section 21 of the Local Government Code of 1991 (RA 7160).

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to enact the following:

SECTION 1. SCOPE AND LIMITATION. This Ordinance shall cover certain portions of Gonzaga Street from Corner Bonifacio to corner Del Rosario Street; Del Rosario Street on the western side of the Central Market; and Gomez Street corner Del Rosario Street to corner Bonifacio Street, surrounding the Central Public Market which are declared temporarily closed from vehicular traffic from July 30, 2015 to September 17, 2016 for the conduct of the "Presyo Agawid"/Flea Market bargain sale of consumer goods and products in connection with the 292nd Annual Fiesta of Tuguegarao City.

This Ordinance shall also cover a portion of Bonifacio Street which shall be closed for certain activities on August 8 to 12, 2016, 6:00-9:00 A.M. and 12:00 NN to 3:00 P.M. and August 13, 2016, 5:00 A.M. to 2:00 P.M.

SECTION 2. INFORMATION. This Ordinance shall be disseminated through all mass media outlets in Tuguegarao City.

SECTION 3. IMPLEMENTATION. The Implementing Agency shall be the Office of the City Chief of Police in coordination with the City General Services Office and Market Supervisors.

The City Chief of Police shall adopt a system of rerouting traffic in the affected streets, provide adequate loading, unloading and parking areas as well as appropriate access and outlets for firefighting trucks and equipment in case of emergency.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon approval.


On motion of Hon. Kendrick S. Calubaquib and with all Members present voting in favor, **CITY ORDINANCE NO. 07-2016** was **UNANIMOUSLY APPROVED** in plenary under suspended rules.

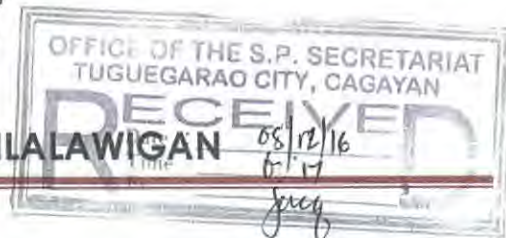


