CITY ORDINANCE NO. 09-2016

**AN ORDINANCE PERMANENTLY CLOSING PORTION OF VALENZUELA STREET,
BARANGAY CENTRO 10, TUGUEGARAO CITY CONSISTING OF NOT MORE THAN
ONE HUNDRED SQUARE METERS**

WHEREAS, pursuant to Section 21 (a) and (b) of Republic Act 7160, otherwise known as the Local Government Code, the Local Government Unit of Tuguegarao City is authorized to close any local road falling within the jurisdiction;

WHEREAS, Barangay Centro 10 Punong Barangay and Kagawads forwarded to the Seventh City Council a Barangay Resolution to withdraw from public use that portion of Valenzuela Street, corner Gonzaga Street, Barangay Centro 10, Tuguegarao City, where the Barangay Centro 10 Multi-Purpose Hall is erected;

WHEREAS, the Joint Committee on Rules, Laws and Ethics, Committee on Barangay Affairs and Committee on Infrastructure and Public Utilities, after a committee meeting, recommend the permanent closure of not more than one hundred (100) square meters area which is already used as a Multi-Purpose Hall;

WHEREAS, in order for the LGU of Barangay Centro 10 to immediately prosecute civil works for the repair, rehabilitation and the new construction of improvements deemed necessary for public purpose, the subject portion of Valenzuela Street should be permanently closed;

WHEREAS, the request is in order, necessary and beneficial to the constituents of Barangay Centro 10 since the closure is for public purpose and that the portion of said street sought to be permanently closed will not impede the ingress and egress for public conveyance and will prevent road accidents.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to enact the following:

SECTION 1. SCOPE AND LIMITATION. This Ordinance shall cover the permanent closure of the portion of Valenzuela Street, corner Gonzaga Street, Barangay Centro 10, Tuguegarao City, consisting of not more than one hundred (100) square meters more particularly the site or location of the present Multi-Purpose Hall.

SECTION 2. INFORMATION. The implementing Agency shall be the Office of the Punong Barangay of Centro 10.


SECTION 3. SEPARABILITY CLAUSE. If for any reason that any section or provisions of this ordinance is declared unconstitutional by the Constitution and other laws and statutes, other sections or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon approval.

On motion of Hon. Raymund P. Guzman, duly seconded by Hon. Danilo L. Baccay and without any objection, **CITY ORDINANCE NO. 09-2016** was **UNANIMOUSLY APPROVED** in plenary under suspended rules.
