**ORDINANCE AUTHORIZING THE REALIGNMENT OF THE CONTINUING  
APPROPRIATION UNDER THE CAPITAL OUTLAY OF THE OFFICE OF THE MAYOR;  
SUPPLEMENTAL BUDGET NO. 01-2015 IN THE AMOUNT OF P830,000.00  
FOR THE IMPROVEMENT OF THE SPA BUILDING, CNHS TO FURNITURE  
AND FIXTURES AND OFFICE EQUIPMENT**

**WHEREAS**, the amount of P830,000.00 for the improvement of SPA Building, Cagayan National High School (CNHS) was allocated in Appropriation Ordinance No. 02-2015 authorizing for Supplemental Budget No. 01-2015 for CY 2015 of the City under the Capital Outlay of the Office of the City Mayor;

**WHEREAS**, the Department of Education issued the Sub-Allotment Release Order (SARO) dated April 01, 2016 indicating the amount of P12,882,948.52 for the construction of Division Office Building which included the SPA Building;

**WHEREAS**, based on the above cited reason, the City Mayor has favorably endorsed to the City Council the request of Ms. Leila P. Areola, Ph.D., OIC, Office of the School Division Superintendent, Tuguegarao City, the request for realignment of the amount of P830,000.00 of the continuing appropriations under the Capital Outlay of the Office of the City Mayor as per Supplemental Budget No. 11-2015 of Tuguegarao City.

**NOW THEREFORE**, premises considered, be it **ORDAINED** in session assembled of the Seventh City Council to enact the following Ordinance:

**SECTION 1.** The amount of P830,000.00 for the improvement of the SPA Building from the continuing appropriation under the Capital Outlay of the Office of the City Mayor, Supplemental Budget No. 01-2015 of Tuguegarao City is hereby re-aligned to purchase the following:


