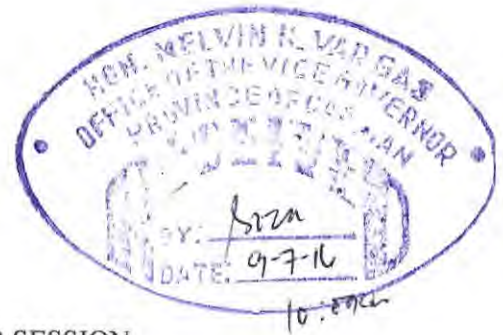

CITY ORDINANCE NO. 12-2016

**ORDINANCE INSTITUTIONALIZING THE CONDUCT OF BARANGAY
PEOPLE'S DAY WITHIN THE TERRITORIAL JURISDICTION OF TUGUEGARAO CITY
AND PROVIDING FUNDS THEREOF**

WHEREAS, under Chapter 2, Section 17 of the Local Government Code (LGC), it is the obligation of the Local Government Unit (LGU) to provide basic services to the barangays;

WHEREAS, the conduct of the Barangay People's Day in the Barangays will give opportunity to the constituents of the Barangays to avail the services of the Tuguegarao City Government;

WHEREAS, the conduct of the Barangay People's Day will bring the City Government closer to the people;

WHEREAS, the conduct of the said Barangay People's Day will ensure the participation of the people in local governance.

NOW THEREFORE, be it **ORDAINED** by the Seventh City Council in session assembled:

SECTION 1. There shall be a Barangay People's Day to be held in every barangay within Tuguegarao City.

SECTION 2. The Barangay People's Day shall be held once a week which shall be in any day of the week to be determined by the City Mayor.

SECTION 3. All departments and offices of the Tuguegarao City Government shall provide technical and administrative support in the conduct of the Barangay People's Day.

SECTION 4. All department heads and offices involved shall provide the proper information to the people relative to the services their respective offices or departments offer.

SECTION 5. Heads of departments and offices of the Tuguegarao City Government shall be held administratively liable for failure of their respective departments or offices to comply with the provisions of this Ordinance.

SECTION 6. The City Mayor shall adopt within thirty (30) days upon approval of this Ordinance an Implementing Rules and Regulations for the efficient implementation of this Ordinance.

SECTION 7. National line agencies are also enjoined to participate in the Barangay People's Day.

SECTION 8. APPROPRIATION/FUNDING. The funding of the conduct of the Barangay People's Day shall be appropriated and authorized in the Annual Budget or Supplemental Budget.

SECTION 9. ACCOUNTABILITY. That all disbursements shall be in accordance with the prescribed guidelines, subject to the usual accounting and auditing rules and regulations.

SECTION 11. REPEALING CLAUSE. City Ordinances or Resolutions which are inconsistent with the provisions of this City Ordinance are hereby modified or repealed accordingly.

SECTION 12. SEPARABILITY CLAUSE. Should any section or provision of this City Ordinance be declared as unconstitutional or invalid, other provisions which are not affected thereby shall continue to be in full force and effect.

SECTION 13. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.

On motion of Hon. Raymund P. Guzman, with twelve (12) members voting in favor, none against and one (1) abstention, **CITY ORDINANCE NO. 12-2016** was **APPROVED** under suspended rules.


