

WHEREAS, Section 12, Article 12 of the Philippine Constitution provides that “the state shall promote the preferential use of Filipino labor, domestic materials and locally produced goods, and adopt measures that help make them competitive;

WHEREAS, Section 458 (1) of the Local Government Code of the Philippines provides among others that the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of the same code;

WHEREAS, over the years, Tuguegaraoños have engaged in business that promotes their capability in the manufacture of processed food and fabrication of merchandise items such as home decors, clothing and other souvenir items;

WHEREAS, locally produced goods and/or products, whether by small or big entrepreneurs, use locally grown crops and are of excellent quality, thereby promoting the rich culture and heritage of Tuguegaraoños;

WHEREAS, the above mentioned products are now available for public consumption and are displayed in some grocery stores and big establishments in the city;
