

CITY ORDINANCE NO. 16-2016

CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE OF ROAD PENDING CONSTRUCTION OF MASONRY DRAINAGE ALONG LUNA STREET ENTERING MAGALLANES STREET OF BARANGAY CENTRO 03, TUGUEGARAO CITY FROM OCTOBER 04, 2016 UP TO CTOBER 31, 2016

WHEREAS, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code, the Local Government Unit of Tuguegarao is authorized to close some of the local roads falling within its jurisdiction;

WHEREAS, the Punong Barangay of Centro 03 requested for the temporary closure of road along Luna Street entering Magallanes Street until the completion of the construction of Masonry Drainage in the said area;

WHEREAS, a construction of Masonry Drainage is going on along Magallanes Street, particularly in front of Bureau of Fire Protection;

WHEREAS, expected pile of diggings will be dumped along road sides which will cause traffic on the said area;

WHEREAS, there is a necessity of withholding from vehicular traffic the said streets for the purpose of Construction of Masonry Drainage in accordance with the provisions of Section 21 of the Local Government Code of 1991 (RA 7160).

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to enact the following:

SECTION 1. SCOPE AND LIMITATION. This Ordinance shall cover along Luna Street entering Magallanes Street, particularly in front of Bureau of Fire Protection Office, Barangay Centro 03, Tuguegarao City.

SECTION 2. IMPLEMENTATION. The Implementing Agency shall be the Office of the Punong Barangay of Centro 03.

The City Chief of Police shall adopt a system of rerouting traffic in the affected streets, provide adequate loading, unloading and parking areas as well as appropriate access and outlets for firefighting trucks and equipment in case of emergency.

SECTION 3. SEPARABILITY CLAUSE. If for any reason that any section or provision of this ordinance is declared unconstitutional by the Constitution and other laws and statutes, other sections or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon approval.

On motion of Hon. Kendrick S. Calubaquib, duly seconded by Hon. Winnoco R. Abraham and without any objection, **CITY ORDINANCE NO. 16-2016** was **APPROVED** in plenary under suspended rules.
