AN ORDINANCE EXEMPTING INDIGENTS FROM THE PAYMENT OF FILING AND CERTAIN FEES BEING COLLECTED BY THE OFFICE OF THE CITY CIVIL REGISTRAR PURSUANT TO REPUBLIC ACT 9048 AS AMENDED BY REPUBLIC ACT 10172

WHEREAS, Republic Act No. 9048, otherwise known as Gunigundo Law, authorizes the city or municipal civil registrar or the consul general to correct a clerical or typographical error in an entry and/or change of first name or nickname in the civil register without need of a judicial order;

WHEREAS, Republic Act No. 10172 further authorizes the city or municipal civil registrar or the consul general to correct clerical or typographical errors in the day and month in the date of birth or sex of a person appearing in the civil register without need of a judicial order, amending for this purpose Republic Act No. 9048;

WHEREAS, through the enactment of the said laws, many were relieved that the correction of clerical or typographical error, change of first name or nickname, clerical or typographical errors in the day and month in the date of birth and sex/gender in the birth records of concerned individual would

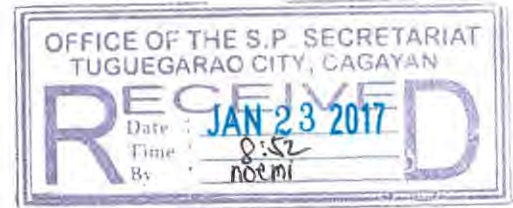
