CITY ORDINANCE NO. 20-2016

AN ORDINANCE INSTITUTIONALIZING THE TUGUEGARAO CITY ANTI-DRUG ABUSE COUNCIL AND PROVIDING FUNDS THEREOF

WHEREAS, it is a declared policy of the state to provide effective mechanisms to re-integrate into society individuals who have fallen victims to drug abuse through sustainable programs of treatment and rehabilitation;

WHEREAS, the Constitution mandates that the government shall promote quality of life of the people. Towards this end, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that Local Government Units shall pursue undertaking to improve public morals and maintain peace and order among other equally significant concerns;





WHEREAS, pursuant to DILG Memorandum Circular No. 2009-09, an emphasis on the primary responsibilities of the local authorities in support of overall government efforts to address illegal drugs and other substance was made;

WHEREAS, as required under Sections 51 to 53 of Republic Act 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002, Local Chief Executives and Sangguniang Members must ensure the mandatory inclusion in the Local Annual Budget of a sustainable appropriation that can adequately enhance the enforcement of RA 9165 giving priority to preventive programs and the rehabilitation of drug dependents, and cause the enactment of an Ordinance complementing the Comprehensive Drugs Act of 2002 if none has yet been passed, or to amend the same to be consistent with the provisions of the said Act, and ensure the effective enforcement thereof;

WHEREAS, the damaging effects of illegal drugs to family life and community peace and harmony has significantly contributed to the increasing incidents of heinous crime.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of Tuguegarao in session assembled, that:

SECTION 1. Title. This Ordinance shall be known and cited as "An Ordinance Institutionalizing the Tuguegarao City Anti-Drug Abuse Council."

SECTION 2. Composition. The Tuguegarao City Anti-Drug Abuse Council ("Council") shall be composed as follows:

Vice Chairman	- L	Chief of Police
Members	-	City Social Welfare and Development Officer
		City Health Officer
		NGO Representative
		Religious Sector Representative
		Chairman/Duly Authorized Representative of the City Council

SECTION 3. Duties and Functions. The Tuguegarao City Anti-Drug Abuse Council shall have the following functions:

- 1. The City Mayor in his capacity as Chairman of the Council shall have the following responsibilities:
 - a. Call on the local PNP, pursuant to his power of operational supervision and control over the local PNP under Section 51 (a) of RA 6975 as amended by Section 62 of RA 8551, to conduct periodic or unannounced onsite inspection of dens, resorts, bars, karaoke bars, nightclubs and other establishments or houses suspected of being used as drug dens or places of sale or delivery of illegal drugs.
 - b. Direct the City Budget Officer to review the local budget to determine if there is an allocation for anti-drug activities, and, if possible, realign the budget to include such activities if otherwise, with focus on the following:
 - i. Purchase of equipage for Anti-Illegal Drug Operations;
 - ii. Development and Dissemination of Advocacy Materials for the Anti-Illegal Drug Campaign;
 - iii. Implementation for the Drug Free-Workplace Program;
 - iv. Adoption of local Anti-Illegal Drug Text and Call Hotlines;
 - v. Support to Anti-Illegal Drug Activities of component barangays; and,
 - vi. Planning Processes for the Peace and Order and Public Safety Plan

 Revoke the business permit of any business establishment found to be the site of the deliveries, sale and use of illegal drugs and substances; and,

d. Cause the reparation of confidential watch-list of drug users and pushers found in the City's area of jurisdiction to be submitted to the PNP Anti-Illegal Drug Task Force for the latter's validation or verification leading to the arrest and filing of appropriate charges.

- Serve as focal point through which various organizations and individuals work together cooperatively in the planning, implementation and evaluation of programs on drug abuse prevention;
- Initiate the formulation of preventive and rehabilitation programs, and ensure the sustainability thereof;
- 4. Coordinate with the PNP, PDEA and DDB for drug-clearing operations;
- Coordinate with the DSWD, DOH, NGOs, CSOs or private rehabilitation centers for the rehabilitation and after-care of drug users;
- Implement the Drug-Free Workplace Program and support other programs, projects and activities on anti-drug abuse; and,
- 7. Perform other related responsibilities which may be assigned by competent authorities.

SECTION 4. Secretariat. There shall be an Anti-Drug Abuse Council Secretariat which shall handle the administrative and technical activities of the Council. Specifically, the Secretariat shall:

- a. Prepare plans and programs for the consideration of the Council;
- b. Supervise, direct and monitor for the council implementation of approved policies, plans and programs;
- c. Undertake the coordination of activities with appropriate agencies of the government; and,
- d. Provide a forum for interdisciplinary dialogue and deliberation of major issues and problems affecting anti-drug abuse problems.

The Secretariat of the Council shall be headed by the City Social Welfare and Development Officer of the Office of the City Social Welfare and Development.

SECTION 5. Meetings. The Council shall meet regularly at least once every month or as often as may be necessary upon the call of the Chairman.

SECTION 6. Appropriations. The amount herein required shall be charged against the annual budget of the city and such amount shall be given priority appropriation and shall be integrated in the annual budgetary allocation.

SECTION 7. Effectivity Clause. This ordinance shall take effect immediately upon its approval.

On motion of Hon. Jude T. Bayona, and without any objection, CITY ORDINANCE NO. 20-2016 was APPROVED in plenary on its Third and Final Reading under suspended rules.
