

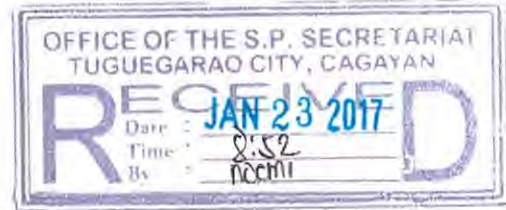





CITY ORDINANCE NO. 26-2016

**AN ORDINANCE GRANTING A CASH AWARD OF TEN THOUSAND PESOS (P10,000.00)
TO TUGUEGARAOÑO CENTENARIANS**

WHEREAS, the City Government of Tuguegarao, in recognition of the invaluable contribution of Senior Citizens to nation building, grants benefits and privileges to Senior Citizens pursuant to the objectives of Republic Act No. 9994, otherwise known as the Expanded Senior Citizens Act of 2010 and Republic Act 10868 otherwise known as Centenarians Act of 2016;

WHEREAS, Section 3 of Centenarians Act of 2016 specifically provides that "as part of the annual Elderly Filipino Week, October 1 to 7, the first Sunday of October is hereby declared as National Respect for Centenarians Day during which, all Filipinos who have turned centenarian in the current fiscal year shall be awarded a plaque of recognition and a cash incentive by their respective city or municipal governments in appropriate ceremonies in addition to the letter of Felicitation and Centenarian Gift provided in Section 2. The local government unit concerned shall determine the amount of the cash incentive;"

WHEREAS, living to a hundred years old is a rarity in this day and age with the modern lifestyle and ways of many Filipinos, hence, maintaining a healthy and active life has become a challenge;

WHEREAS, the City Government of Tuguegarao should lead in paying respect to Tuguegaraoño centenarians and according them the necessary assistance they need;

WHEREAS, the grant of special award to centenarians of the City of Tuguegarao is a program that is well-received and appreciated by the Senior Citizens who, in the twilight of their years, value and long for affection and recognition above anything else;

WHEREAS, it is the intention of the Ordinance therefore to provide incentives to the Tuguegaraoño centenarians and to honor individuals who have lived to a hundred and over, considering that this event is in fact a reason for great celebration.

NOW THEREFORE, be it **ENACTED**, as it is hereby **ENACTED**, by the Sangguniang Panlungsod in a regular session duly assembled that:

SECTION 1. TITLE. This Ordinance shall be known as “An Ordinance Granting a Cash Award of Ten Thousand Pesos (P10,000.00) to Tuguegaraoño Centenarians” or “The Tuguegaraoño Centenarian Cash Award Ordinance.”

SECTION 2. CENTENARIAN CASH AWARD. Senior Citizens who are residents of the City of Tuguegarao and who have reached the age of One Hundred (100) years on August 16, 2016 or those who may thereafter reach said age are entitled to claim one-time cash award of Ten Thousand Pesos (P10,000.00) from the Office of Senior Citizen Affairs (OSCA) of Tuguegarao City.

SECTION 3. ELIGIBILITY REQUIREMENTS. To be eligible to claim the cash award as provided in this Ordinance, the prospective recipient must be:

- a. A bona fide resident of the City of Tuguegarao;
- b. A holder of a Tuguegarao Senior Citizen Identification Card;
- c. Has reached One Hundred (100) years old; and,
- d. Not a prior recipient of the same cash award.

SECTION 4. SOURCE OF FUNDING. The funds to finance this Ordinance shall be appropriated in the Annual Budget and/or Supplemental Budget of the City.

SECTION 5. REPEALING CLAUSE. All ordinances and resolutions which are inconsistent with this Ordinance shall be deemed repealed or modified accordingly.


SECTION 6. SEPARABILITY CLAUSE. In the event that a part of this Ordinance be declared by the courts as unconstitutional or invalid, the remaining parts thereof shall be valid and effective.

SECTION 7. EFFECTIVITY. This Ordinance shall take effect immediately upon posting in three (3) conspicuous places in the City.

On motion of Hon. Raymund P. Guzman and without any objection, **CITY ORDINANCE NO. 26-2016** was **APPROVED** on its Third and Final Reading under suspended rules.
