**CITY RESOLUTION NO. 005-2016**

**A RESOLUTION REQUESTING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, THROUGH THE CITY CHARACTER COUNCIL TO DISSEMINATE THE GOOD DEED OF MR. LORENZO T. PATINO BY DISPLAYING HIS NAME AND PICTURE AT THE TRICYCLE REGULATION UNIT (TRU) OFFICE AND OTHER CONSPICUOUS PLACES OF THE CITY HALL BUILDING**

**WHEREAS**, Mr. Lorenzo T. Patino, a tricycle driver from Atulayan, Tuguegarao City, returned to Bombo Radyo on January 10, 2016 a bag left by Mrs. Rebecca Bumanglag, a cash amounting to Four Thousand Pesos (P4,000.00) and checks amounting to Two Hundred Ninety Nine Thousand Pesos (P299,000.00) with a grand total of Three Hundred Three Thousand Pesos (P303,000.00);

**WHEREAS**, Mr. Patino has been awarded City Resolution No. 004-2016 "*A Resolution Giving Recognition and Commendation to Mr. Lorenzo T. Patino, a Tricycle Driver and a Resident of Atulayan, Tuguegarao City, for his Exemplary Act of Honesty*" by the Sixth City Council in recognition of his honesty;

**WHEREAS**, the exemplary act of Mr. Patino is worthy of emulation by his fellow tricycle drivers as well as by all Tuguegaraceños;

**WHEREAS**, there is a need to disseminate the good deed of Mr. Patino in consonance with the provisions of City Ordinance No. 04-2013, otherwise known as the "*Character City Ordinance of Tuguegarao City*", to motivate others to do the same.

**NOW THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to request the City Mayor, Hon. Atty. Jefferson P. Soriano, through the City Character Council, to disseminate the good deed of Mr. Patino by displaying his name and picture at the Tricycle Regulation Unit (TRU) Office and other conspicuous places of the City Hall Building.


**RESOLVED FURTHER**, that the TRU shall do the same for all other tricycle drivers who shall display exemplary acts.
