A RESOLUTION GRANTING EXTENSION OF THE RENEWAL OF BUSINESS LICENSES AND MAYOR'S PERMITS UNTIL FEBRUARY 15, 2016

WHEREAS, Section 167 of the Local Government Code states that "unless otherwise provided in this Code, all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case maybe. The Sanggunian concerned may, for a justifiable reason or cause, extend the time for payment of such taxes, fees or charges without surcharges or penalties, but only for a period not exceeding six (6) months;"

WHEREAS, the last day of filing of applications for renewal of Business Licenses and Mayor's Permits was January 31, 2016 as per Local Revenue Ordinance of the City;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested for a 15-day extension for payment of business tax through a letter dated January 29, 2016 addressed to the Sixth City Council;

WHEREAS, there is an imperative need to extend the deadline to give ample time for applicants who failed to meet the deadline to comply with the requirements for the renewal of business licenses and Mayor's Permits;

WHEREAS, the extension of the said deadline would benefit the constituents of Tuguegarao City especially those in the business sector.

NOW THEREFORE, RESOLVE, as it is hereby RESOLVED, to grant extension of the renewal of business licenses and Mayor's Permits until February 15, 2016.

RESOLVED FURTHER, that during the period of extension, no interest and surcharges shall be imposed on the applicants.

On motion of Hon.Jude T. Bayona, duly seconded by Hon. Estelita U. Dayag and without any objection from the Body, CITY RESOLUTION NO. 047-2016 was UNANIMOUSLY APPROVED on its Third and Final Reading under suspended rules.
