CITY GOVERNMENT FOR THE "ADOPT-AN-ESTERO PROGRAM"**

WHEREAS, the "Adopt-an-Estero Program" is a collaborative undertaking among the Estero Communities, Donor-Partner, Local Government Unit/s, other government agencies and the Department of Environment and Natural Resources (DENR);

WHEREAS, the Department of Environment and Natural Resources–Environment Management Bureau (DENR-EMB) recognizes the vital role of the community as partners of the local government unit/s in achieving a cleaner, safer and healthier environment;

WHEREAS, the City Government of Tuguegarao supports the "Adopt-an-Estero Program" by active participation in the actual clean-up of wastes, debris and silt and by implementing and preparing plans to sustain a clean estero and reducing water borne diseases.

NOW THEREFORE RESOLVED, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign and execute a Memorandum of Agreement with the DENR-EMB RO2 for and in behalf of the Tuguegarao City Government the "Adopt-an-Estero Program."


