# **CITY RESOLUTION NO. 054-2016**

RESOLUTION AUTHORIZING TUGUEGARAO CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS FOR THE INSTALLATION OF TRAFFIC SIGNAL LIGHTS

WHEREAS, the Department of Public Works and Highways (DPWH) through the Cagayan Third Engineering District is tasked to undertake the installation of Traffic Signal Lights along the following road section/s:

- 1. Philippine Highway Balzain-Diversion Road Intersection, Tuguegarao City;
- 2. Buntun Highway/Luna Street-Diversion Road Intersection, Tuguegarao City; and,
- 3. A Luna Street-A Mabini Street Intersection, Tuguegarao City

WHEREAS, the Tuguegarao City Government has agreed to accept the Project and commits to secure and undertake the maintenance thereof, including the payment of the corresponding electric bills and other related expenses;

WHEREAS, the DPWH shall receive the funds and ensure the prompt implementation of the project in accordance with the approved plans and programs of work;

WHEREAS, the DPWH shall provide training for LGU Tuguegarao City on the operation, maintenance and repair of the traffic lights;

WHEREAS, the parties hereby agree to execute the required Memorandum of Agreement subject to the terms and conditions hereinafter setforth;

WHEREAS, the parties represent that they have the requisite power, authority and capacity to enter into an agreement and perform their obligations as stipulated in the Memorandum of Agreement.



NOW THEREFORE, RESOLVE, as it is hereby RESOLVED, to authorize the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Public Works and Highways for the installation of Traffic Signal Lights.

On motion of Hon. Noel A. Mora and with all Members present voting in favor, CITY RESOLUTION NO. 054-2016 was UNANIMOUSLY APPROVED under suspended rules.
