**CITY RESOLUTION NO. 072-2016**

**RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE OF TUGUEGARAO CITY TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE RENEWAL OF THE CONTRACT OF LEASE WITH THE PHILIPPINE STATISTICS AUTHORITY**

**WHEREAS**, the Philippine Statistics Authority (PSA) has signified its intention to renew its contract of lease of the building owned by the Tuguegarao City Government with a total area of 789.75 square meters more or less for use as office space;

**WHEREAS**, the Tuguegarao City Government is the legitimate owner of the building located at the Tuguegarao City Hall Compound, Tuguegarao City, Cagayan;

**WHEREAS**, the Sixth City Council, through the Committee on Laws, Ordinances, Revisions and Legal Matters, studied the provisions stipulated in Contract of Lease;

**WHEREAS**, the committee found the terms and conditions beneficial to both parties;

**WHEREAS**, the monthly rental is thirty two thousand five hundred ninety two (P32,592.00) Philippine currency, which is equivalent to forty seven and 78/100 pesos (₱7.78) per square meter;

**WHEREAS**, this Contract of Lease shall be approved by proper authorities and that the Philippine Statistics Authority (PSA) agrees to the terms and conditions stipulated in the contract of lease.


**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to authorize the Local Chief Executive of Tuguegarao City to sign for and in behalf of the Tuguegarao City Government the Contract of Lease with the Philippine Statistics Authority, represented by its OIC Regional Director, Marilyn T. Estrada, for the use of the building as office space located at the Tuguegarao City Hall Compound, Tuguegarao City, Cagayan.

**RESOLVED FURTHER**, that the resolution shall give the Contract of Lease its effectivity from January 04, 2016 to December 31, 2016.


