**A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA)

THE CAGAYAN NATIONAL HIGH SCHOOL FOR THE TEMPORARY USE OF THE
MUSICAL INSTRUMENTS FOR THE TUGUEGARAO CITY YOUTH BRASS BAND**

WHEREAS, Section 2 (b) of Republic Act No. 8044 "*Youth in Nation Building Act*" directs the "*mobilization of youth's abilities, talents and skills...*";

WHEREAS, the discovery, development and furtherance of the musical abilities and skills of the youth is one aim of Tuguegarao City in support of RA 8044;

WHEREAS, for this purpose, the Tuguegarao City Youth Brass Band was created by virtue of City Ordinance No. 05-2016 "*An Ordinance Creating the Tuguegarao City Youth Brass Band and Providing Funds Therefor*";

WHEREAS, in order to maximize fully the potentials of the members of the Brass Band, there is a need for musical instruments to be used;

WHEREAS, the Tuguegarao City Brass Band shall make use of the musical instruments of the Cagayan National High School during the initial year of the implementation of the ordinance until such time that the needed musical instruments shall have been procured by the City Government of Tuguegarao.

NOW THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement (MOA) and to authorize the Local Chief Executive, to sign and enter for and on behalf of the Tuguegarao City Government the said MOA with the Cagayan National High School through its OIC-Principal, Dr. Esmeralda Ugaddan, Head Teacher VI, for the temporary use of their musical instruments.

RESOLVED FURTHER, that a copy of this Resolution be given to the Local Chief Executive and OIC-Principal of Cagayan National High School, Dr. Esmeralda Ugaddan, Head Teacher VI, for information and action.


