**CITY RESOLUTION NO. 092-2016**

**RESOLUTION APPROVING THE REQUEST OF MS. LOLITA M. CABAUG  
FOR A RESOLUTION OF NO OBJECTION (RONO) AS A PRE-REQUISITE  
IN ESTABLISHMENT AND OPERATION OF AN ELECTRONIC BINGO BOUTIQUE  
AT BARANGAY BUNTUN, TUGUEGARAO CITY**

**WHEREAS**, Ms. Lolita M. Cabahug, Proprietor, Cabahug Gaming Enterprise, requested for a Resolution of No Objection (RONO) from the Sanggunian as part of the requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) in the establishment and operation of an electronic bingo boutique at Barangay Buntun, Tuguegarao City;

**WHEREAS**, Ms. Lolita M. Cabahug has complied with the following documentary requirements:

- a. Department of Trade and Industry Certificate of Business Name Registration
- b. Annual Personal Disclosure Statement (PDS)
- c. Special Power of Attorney authorizing Mr. Jonathan A. Baluscang to represent the applicant in her application to establish and operate an electronic bingo boutique

**WHEREAS**, the Committee on Games and Amusement conducted a public hearing on February 03, 2016 to solicit the sentiments/opinions of the residents of Barangay Buntun relative to the operation of an electronic bingo boutique in said barangay. No objections were raised and that the management shall prioritize employment of qualified residents from Barangay Buntun;

**WHEREAS**, Committee Report No. 03-2016 of the Committee on Games and Amusement recommending the passage of a Resolution of No Objection (RONO) as a pre-requisite in the establishment and operation of an electronic bingo boutique at Barangay Buntun, Tuguegarao City was duly adopted during the June 07, 2016 Regular Session of the Sangguniang Panlungsod;

**WHEREAS**, the failure of Cabahug Gaming Enterprise to follow the operational procedures of PAGCOR and/or its engagement in unscrupulous transactions shall be a ground for the revocation and cancellation of its RONO;




**WHEREAS**, the operation of Cabahug Gaming Enterprise shall be governed and subjected to the provisions of local laws and ordinances of Tuguegarao City.

**NOW THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the request of Ms. Lolita M. Cabahug for a Resolution of No Objection (RONO) as a pre-requisite in the establishment and operation of an electronic bingo boutique at Buntun, Tuguegarao City, subject however, to compliance with the PAGCOR guidelines on the operation of electronic bingo boutique.


