CONDOLENCES TO HIS FAMILY FOR HIS DEMISE**

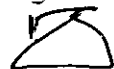

Tuguegarao, for his invaluable service to the people of Tuguegarao and to express heartfelt condolences to his family.


RESOLVED FURTHER, to extend the commiseration of the people of Tuguegarao City to the family of Hon. Vicente Limqueco.
