**A RESOLUTION APPROVING THE COMPOSITION OF THE REGULAR COMMITTEES
OF THE SEVENTH CITY COUNCIL**

WHEREAS, Rule VIII, Section 14 of City Resolution No. 098-2016 titled "*Resolution Updating the Existing Internal Rules of Procedure of the Sangguniang Panlungsod of Tuguegarao*" states that:

"A regular committee shall be composed of a chairman, vice chairman and three (3) members. The chairman of each committee shall be elected by the members of the Sangguniang Panlungsod except for the Oversight Committee whose chairman shall be the Presiding Officer. The vice chairman and the members of each committee shall be nominated by the chairman thereof whose nomination shall be confirmed by the members of the Sangguniang Panlungsod. Provided, that the sectoral representatives, the President of the Liga ng mga Barangay and the Sangguniang Kabataan President shall ipso facto chair the committees corresponding to their respective sectors";

WHEREAS, pursuant to the above-cited rule, the Body nominated and elected for the different chairmanships of the regular committees during the July 5, 2016 Regular Session after the Internal Rules of Procedure was approved;
