RESOLUTION CHANGING THE PROJECT NAME OF THE BOTTOM-UP-BUDGETING (BUB) PROJECT FOR CALENDAR YEAR (CY) 2016 FROM RICE PROGRAM SPRING DEVELOPMENT PROJECT TO RICE PROGRAM-SHALLOW TUBE WELL PROJECT IN LARION ALTO, TUGUEGARAO CITY

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, through a letter dated July 4, 2016, requested the Seventh City Council for a resolution changing the Rice Program Spring Development Project to Rice Program-Shallow Tube Well in Larion Alto, Tuguegarao City;

WHEREAS, attached to the letter request of the City Mayor, Hon. Atty. Jefferson P. Soriano, is Resolution No. 05-2016 for the change of the said project, approved by the members of the Tuguegarao City Local Poverty Reduction Action Team (LPRAT);

WHEREAS, the Rice Program Spring Development Project in Larion Alto, a Bottom-Up Budgeting (BuB) Project for CY 2016 of Tuguegarao City, was not feasible in the area because the existing creek has no water during dry season based on the resolution of the Local Poverty Reduction Action Team and the findings of the joint committees of the Committee on Agriculture and Food and Committee on Rules, Laws and Ethics;

WHEREAS, the Rice Program-Shallow Tube Well Project is more feasible means of sourcing water to cater the needs of the farmers in order to intensify irrigation efficiency as per findings of the joint committees of the Committee on Agriculture and Food and the Committee on Rules, Laws and Ethics;

WHEREAS, since only the project name will be changed, the project location and beneficiaries shall be maintained.


