WHEREAS, F/S Insp. Aristotle V. Atal, City Fire Marshal of the Tuguegarao City Fire Station, reported to the Committee on Public Order and Safety and Disaster Preparedness in its committee meeting on July 8, 2016 that fifteen (15) fire personnel of the said station have been relieved and reassigned to different stations;

WHEREAS, the relief of the fifteen (15) fire personnel from the City Fire Station, with no replacements effected, has adversely affected the operation of said station with fire trucks laid idle which will definitely cause problems in the event that fire incidents would occur in the city;

WHEREAS, there is a compelling need to look into the facts and circumstances in the relief of the numerous fire personnel to determine its justifiability in order to institute corrective legislative measure to ensure that personnel actions in the reassignment or movement of employees who are not covered by the forty-hour work week because of the exigency of the service will not be disregarded nor compromise public service in times of emergency.

NOW THEREFORE, RESOLVE, as it is hereby RESOLVED, to inquire into the reported relief of fifteen (15) personnel of the Tuguegarao City Fire Station in aid of legislation.

RESOLVED FURTHER, to set the legislative inquiry on the next scheduled regular session of the Seventh City Council with proper notices transmitted to the Bureau of Fire Protection, Regional Office No. 2 and Office of the Tuguegarao City Fire Station by the Secretary to the Sanggunian.

RESOLVED FINALLY, to furnish copies of this Resolution, to the Offices of the Honorable City Mayor, Atty. Jefferson P. Soriano and the Regional Director, Bureau of Fire Protection, Regional Office No. 2, Tuguegarao City, for their information.
