CITY RESOLUTION NO. 111-2016

RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO TRANSACT, NEGOTIATE AND ENTER INTO A CONTRACT WITH THE BEST TERMS AND CONDITIONS WITH LEGITIMATE AND QUALIFIED OPERATORS AND BUSINESSMEN FROM TUGUEGARAO CITY FOR THE 2016 "PRESYO AGAWID"/FLEA MARKET SUBJECT TO THE RATIFICATION OF THE SEVENTH CITY COUNCIL AND EXISTING APPLICABLE LAWS, RULES AND REGULATIONS

WHEREAS, a traditional and part of the celebration of the 292nd Patronal Feast of Tuguegarao is the "Presyo Agawid"/Flea Market activity which is usually held at the portions of some streets of Tuguegarao City;

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, pursuant to the pertinent provisions of Section 22 of the Local Government Code to transact, negotiate and enter into a contract with the best terms and conditions with legitimate and qualified operators and businessmen from Tuguegarao City, subject to the ratification of the City Council, on the following conditions:

For the operator:

1. To commence the "Presyo Agawid"/Flea Market on July 31, 2016, 12:00 midnight and end on September 15, 2016, 12:00 midnight
2. To secure a Mayor's Permit;
3. To install and dismantle the stalls;
4. To pay the electric and water bills;
5. To maintain the cleanliness and sanitation within the premises;
6. To hire additional sweepers to augment the number of present sweepers;
7. To secure and ensure the safety of their goods and personnel;
8. Not to use flammable materials such as LPG and firewood;
9. Not to extend the time and days of operation;
10. To post a security/surety bond in the amount of One Hundred Thousand Pesos (P100,000.00) to guarantee the performance of the operator's obligations and to answer for whatever damages incurred in the operation of the business; and,

11. To provide six (6) pieces ten-pounder fire extinguishers and coordinate with the fire marshal for the locations.

For the Tuguegarao City Government:


1. To itemize all fees paid by the operator;
2. To re-route the flow of traffic to ensure orderliness;
3. To make sure that a fire truck shall always be available at the vicinity;
4. To provide relocation sites for street vendors;
5. To provide parking spaces for tricycles;
6. To insure public safety, peace and order in the vicinity;
7. To ensure police visibility and augment the number of traffic aides;
8. To provide a scheme in garbage collection;
9. To furnish the City Council a copy of the contracts or offers pertinent to this authority; and,
10. To submit a full report on the implementation of the terms and conditions provided in the instant ordinance two (2) weeks after the period of "Presyo Agawid"/Flea Market.

RESOLVED FURTHER, that the amount of the contract price shall not be lower than One Million Seven Hundred Thousand Pesos (P1,700,000.00), with a thirty percent (30%) down payment upon execution of the contract and the balance shall be paid on or before September 10, 2016, however, if there is no taker, the City Mayor may negotiate for the best terms but not lower than One Million Seven Hundred Thousand Pesos (P1,700,000.00) and, if there is no taker, the amount of One Million Seven Hundred Thousand Pesos (P1,700,000.00) shall be divided among the interested locators.


On motion of Hon. Kenarick S. Calubaquib and without any objection, **CITY RESOLUTION NO. 111-2016** was **UNANIMOUSLY APPROVED** in plenary under suspended rules.
