SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT (MOA) WITH THE INFORMATION COMMUNICATION TECHNOLOGY FOR THE REALIZATION OF FREE WI-FI INTERNET ACCESS IN PUBLIC PLACES PROJECT**

**WHEREAS**, the National Government through the Department of Science and Technology (DOST) Information and Communications Technology Office (ICT) embarks to undertake the free wi-fi internet access in Public Places Project across the Philippines;

**WHEREAS**, to actualize the above undertaking, the DOST Information and Communications Technology Office enters into a Memorandum of Agreement (MOA) with identified Local Government Units (LGUs) for its project;

**WHEREAS**, the project directly in line with the "Internet For All" thrust identified in the Philippine Digital Strategy 2011-2016 aims to accelerate the Government's effort in enhancing internet accessibility for Cagayanos to hasten economic, social, and educational opportunities;

**WHEREAS**, Tuguegarao City is one of the identified LGUs where the project shall be implemented, thereby benefitting the constituents of Tuguegarao City.


