WHEREAS, the Information and Communications Technology (ICT) Office, Department of Science and Technology is currently implementing the infrastructure activities of GovNet project under the program of Integrated Government Philippines (iGovPhil) which aims to address the basic needs of the government for transparency, efficiency and effective governance through ICT;

WHEREAS, Tuguegarao City Government is one of the identified LGU partners for the said project.




