CITY RESOLUTION NO. 126-2016

A RESOLUTION AMENDING CITY RESOLUTION NO. 145-2016 PARTICULARLY ITEM NUMBER 5 OF THE THIRD WHEREAS CLAUSE FROM "CONSTRUCTION" TO "ESTABLISHMENT" OF THE TEMPORARY SHELTER FOR CHILDREN IN CONFLICT WITH THE LAW (CICL)

WHEREAS, City Resolution No. 145-2015, "*Resolution Adopting and Approving CDC Resolution Nos. 3, 6, 7, 8 and 9, Series of 2015, Amending One Item of the ADP 2014 and Four Items of ADP 2015*", was approved by the Sixth City Council;

WHEREAS, one of the CDC Resolutions approved under City Resolution No. 145-2015 is the *Resolution Amending Item of ADP 2015 re: Construction of Temporary Shelter for CICL-GPB with Specific Location at 2/F, Pulisya ti Umili (PTU) Don Domingo, Tuguegarao City*;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested for an amendment of City Resolution No. 145-2015 *re: Construction of Temporary Shelter for CICL-GPB with Specific Location at 2/F, Pulisya ti Umili (PTU) Don Domingo to Improvement/Rehabilitation of Temporary Shelter for CICL-GPB with Specific Location at 2/F, Pulisya ti Umili (PTU) Don Domingo, Tuguegarao City*;

WHEREAS, the Committee on Rules, Laws and Ethics of the Seventh City Council conducted a committee meeting for the said request;

WHEREAS, during the committee meeting, Mr. Franco Lopez, a representative from the Department of Social Welfare and Development (DSWD) RO2, stated that instead of construction/rehabilitation of a temporary CICL shelter, it should be establishment of a temporary CICL shelter;

WHEREAS, the committee found the request to be in order, necessary and beneficial to children in conflict with the law in Tuguegarao City


