CITY RESOLUTION NO. 128-2016

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL FOOD AUTHORITY (NFA) FOR THE RICE LOAN PROGRAM DURING CALAMITIES

WHEREAS, under the Local Government Code (LGC), provinces, cities and municipalities are tasked to provide basic social services including relief assistance in times of calamities;

WHEREAS, the National Food Authority (NFA) is charged with, among others, ensuring the nation's adequate supply and distribution of grains in the country;

WHEREAS, the NFA's Provincial Manager, Mr. Emmanuel L Villanueva, through a letter, expressed intention to renew or enter into a Memorandum of Agreement (MOA) on the Rice Loan Program during calamities with the Tuguegarao City Government during calamities;

WHEREAS, through the Rice Loan Program, the Tuguegarao City Government shall be able to provide immediate assistance during calamities since the program shall give the LGU priority access to NFA rice and allow purchase rice on credit;

WHEREAS, the Seventh City Council, through the joint Committee on Agriculture and Food and Committee on Rules, Laws and Ethics, after having reviewed the terms and conditions in the MOA, found the same to be in order, necessary, favorable and beneficial to the Tuguegarao City Government and to its constituents.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement (MOA) with the National Food Authority (NFA) for the Rice Loan Program during calamities.

RESOLVED FURTHER, to forward a copy of this Resolution to the City Mayor, Hon. Atty. Jefferson P. Soriano, and the National Food Authority (NFA), Provincial Office, for their information.


