GOVERNMENT THE CONTRACT OF SERVICE OF MR. MARK ANGELO M. GACIAS AND
MR. FELIPE Z. FERMIN AS PART OF DEPARTMENT OF HEALTH-RURAL HEALTH
MIDWIVES PLACEMENT PROGRAM (RHMPP)

WHEREAS, under Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code (LGC), the functions and responsibilities for the delivery of basic health services and other related facilities have been transferred from the Department of Health to the Local Government Unit;

WHEREAS, the Department of Health is mandated to provide adequate and appropriate human resource for health in marginalized areas to entail the delivery of quality healthcare services in a devolved Local Government Unit to include the management of clinical, administrative and public health aspects;

WHEREAS, the City of Tuguegarao is an identified priority area of Department of Health as a Rural Health Midwife (RHM) under the Rural Health Midwives Placement Program (RHMPP);

WHEREAS, Mr. Angelo M. Gacias and Mr. Felipe Z. Fermin were two of the beneficiaries of the two (2) year Midwifery Scholarship Program of the Philippines (MSPP);

WHEREAS, Mr. Angelo M. Gacias and Mr. Felipe Z. Fermin consented to serve as per "return service" the City of Tuguegarao being a priority area of Department of Health as a Rural Health Midwife (RHM) under the Rural Health Midwives Placement Program (RHMPP);

WHEREAS, the City Government of Tuguegarao shall provide Mr. Gacias and Mr. Fermin their monthly salaries commensurate to their qualification;

WHEREAS, the Joint Committees studied the contract and, finding it in order, approved the same.

NOW THEREFORE, RESOLVE, as it is hereby RESOLVED, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Contract of Service of Mr. Mark Angelo M. Gacias and Mr. Felipe Z. Fermin as part of Department of Health-Rural Health Midwives Placement Program (RHMPP).

RESOLVED FURTHER, to forward a copy of this Resolution to the City Mayor, Hon. Atty. Jefferson P. Soriano, for his information and appropriate action and to the Department of Health, Region 02 and Tuguegarao City Health Office, for their information and guidance.
