## **CITY RESOLUTION NO. 130-2016**

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR,
HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE
TUGUEGARAO CITY GOVERNMENT THE MEMORANDA OF AGREEMENT (MOA)
WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE),
REGIONAL OFFICE NO. 2, FOR THE IMPLEMENTATION OF THE
DOLE LIVELIHOOD (KABUHAYAN) PROGRAM IN THE VARIOUS
BARANGAYS OF TUGUEGARAO CITY

WHEREAS, the Department of Labor and Employment (DOLE) is mandated to promote employment opportunities and endeavors to contribute in reducing poverty by providing the marginalized workers access to iivelihood undertakings;

WHEREAS, DOLE Regional Office No. 2 has been given the responsibility to implement the DOLE Liverihood (Kabuhayan) Program to enable the unemployed poor, seasonal and low-wage workers to start individual livelihood or collective enterprise undertakings with the goal of moving them out of poverty and making them productive;

WHEREAS, LGU Tuguegarao City has been accredited by DOLE to be capable in implementing the proposed project, particularly the Starter Kit Project (Manicure, Pedicure with Spa, Plumoing and Electrical Installation and Maintenance) with fifty-five (55) beneficiaries and the NEGOKART Project (Balut Penoy, Fishball, Kikiam, Bakai Bote and Meat, Fruit, Vegetable Vending) with sixty-three (63) beneficiaries, in the various barangays of Tuguegarao City;

WHEREAS, after having reviewed the terms and conditions in the Memorandum of Agreement (MOA), the Seventh City Council found the same to be in order, necessary, favorable and beneficial.

NOW THEREFORE, RESOLVE, as it is hereby RESOLVED, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Memoranda of Agreement (MOA) with the Department of Labor and Employment (DOLE), Regional

Office No. 2, for the implementation of the DOLE Livelihood (Kabuhayan) Program in the various barangays of Tuguegarao City.

**RESOLVED FURTHER,** to forward a copy of this Resolution to the City Mayor, Hon. Atty. Jefferson P. Soriano, and the Department of Labor and Employment (DOLE), Regional Office No. 2, for their information and guidance.
