CITY RESOLUTION NO. 133-2016

**A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR,
HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE
TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT (MOA)
WITH THE BUREAU OF FIRE PROTECTION**

WHEREAS, the Bureau of Fire Protection by virtue of DOF-DBM-DILG Joint Circular No. 2015-01 dated February 12, 2015 authorized the release of the twenty percent (20%) share in the Fire Code Revenues to concerned cities/municipalities upon release of Special Allotment Release Order (SARC)/Notice of Cash Allocation (NCA) from the Department of Budget and Management (DBM) for collections for CY 2010, 2011, 2012 and 2013 and for the CY 2014 to 2015 to be directly released to the city/municipality;

WHEREAS, the Tuguegarao City Government shall appropriate the twenty percent (20%) share exclusively for the improvement of maintenance of the city/municipal Bureau of Fire Protection stations to include acquisition of firefighting equipment, service vehicles, investigative construction/repair of city/municipal BFP fire stations;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, endorsed to the Seventh City Council the Memorandum of Agreement (MOA) for perusal and for an authority to enter into the said MOA.

WHEREAS, after an exhaustive discussion during its committee meeting held for the said purpose, the Committee on Rules, Laws and Ethics found the terms and conditions in the MOA to be in order and with merit.


