**CITY RESOLUTION NO. 144-2016**

**A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE-REGIONAL OFFICE NO. 02 FOR THE ALLOCATION OF ONE (1) UNIT CORN MECHANICAL SHELTER TO THE TUGUEGARAO CITY GOVERNMENT**

**WHEREAS**, the Department of Agriculture Regional Field Office No. 02 has launched the Corn Program to boost agricultural productivity;

**WHEREAS**, the Local Government Unit (LGU) of Tuguegarao City is identified as one of the recipients of one (1) unit of corn mechanical sheller;

**WHEREAS**, the corn mechanical sheller shall be given to the City Agriculture and Fishery Council (CAFC) which shall sustain its effective operation and maintenance;

**WHEREAS**, in order to facilitate the perfection of the contract for the herein program, there is a need for a Memorandum of Agreement to be entered into by and between the Tuguegarao City Government, represented by the Hon. City Mayor, Atty. Jefferson P. Soriano, and the Department of Agriculture (DA) Regional Office No. 02 represented by Dr. Lucrecio R. Alviar, Jr. CESO III, Regional Executive Director;

**WHEREAS**, the Seventh City Council, through the Committee on Agriculture and Food, after having reviewed the terms and conditions in the MOA, found the same to be in order and beneficial to the constituents of Tuguegarao City.


