WHEREAS, the Local Government Unit (LGU) of Tuguegarao City is identified as one of the recipients of one (1) unit of corn mechanical sheller;


WHEREAS, the corn mechanical sheller shall be given to the City Agriculture and Fishery Council (CAFC) which shall sustain its effective operation and maintenance;
