CITY RESOLUTION NO. 146-2016

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT WITH THE DEPARTMENT OF EDUCATION – DIVISION OF TUGUEGARAO CITY, NATIONAL COMMISSION ON INDIGENOUS PEOPLES AND INTERIM COUNCIL OF IP/COMMUNITY ELDERS FOR THE CONDUCT OF ETHNICITY MAPPING AND IMPLEMENTATION OF THE INDIGENOUS PEOPLES EDUCATION (IPEd) PROGRAM

WHEREAS, Republic Act (RA) 8371 is an act established to recognize, protect and promote the rights of indigenous cultural communities/indigenous peoples;

WHEREAS, the Department of Education (DepEd), Division of Tuguegarao City as part of its effort to promote the indigenous cultural communities/Indigenous Peoples Education Program (IPEd) aims to orient its partners about the program and has initiated IPEd interventions through ethnicity mapping in consultation with the Indigenous Peoples (IP);

WHEREAS, the National Commission on Indigenous Peoples, a regional government agency responsible of protecting the rights of the Indigenous Peoples (IPs) of the Philippines, has agreed to provide technical assistance in the implementation of ethnicity mapping in Tuguegarao City;

WHEREAS, the Tuguegarao City Government shall provide support to the DepEd Division of Tuguegarao City on the conduct of ethnicity mapping and the implementation of the IPEd Program;

WHEREAS, the purpose of the ethnicity mapping is to establish accurate and reliable information/data on the people of Tuguegarao City as to their origins (banag and Itawes) including other indigenous groups coming from adjacent provinces and/or regions;

WHEREAS, after having reviewed the terms and conditions in the MOA through a committee meeting, the Seventh City Council, through the Committee on Education and Committee on Social Services, found the same to be in order and beneficial to the constituents of Tuguegarao City as a Premier Ibanag City.


NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign the memorandum of Agreement (MOA) for and on behalf of the Tuguegarao City Government with the Department of Education-Division of Tuguegarao City, National Commission on Indigenous People (NICP), and Interim Council of IP/Community Elders for the conduct of ethnicity mapping and implementation of the Indigenous Peoples Education (IPEd) program.

RESOLVED FURTHER, to forward copies of this Resolution to the City Mayor, Hon. Atty. Jefferson P. Soriano, and the Department of Education-Division of Tuguegarao City, National Commission on Indigenous People (NICP) and Interim Council of IP/Community Elders.
