#### CITY RESOLUTION NO. 150-2016

### A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT AND AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REGIONAL FIELD OFFICE NO. 02 REGARDING THE IMPLEMENTATION OF THE SUPPLEMENTARY FEEDING PROGRAM

WHEREAS, the Department of Social Welfare and Development (DSWD), in its mandate to provide social welfare and development programs particularly through technical assistance and resource augmentation, is providing nutrition services to its clients at the local level through the center-based and community-based services in partnership with non-government organizations under the Program Management Bureau, such as Food for School and Healthy Feeding Program in the day care centers which were previously implemented nutrition programs for the DSWD;

WHEREAS, the Supplementary Feeding Program is the provision of food in addition to the regular meals to currently enrolled day care children as part of the DSWD's contribution to the Early Childhood Care and Development (ECCD) Program of the government;

WHEREAS, malnutrition among children is a problem that needs to be addressed by the government, likewise, children who are at risk of malnutrition should also be given equal consideration to prevent them from becoming malnourished.

**NOW THEREFORE, RESOLVE,** as it is hereby **RESOLVED**, to authorize the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Social Welfare and Development Regional Office No. C2, represented by Regional Director Ponciana P. Condoy regarding the implementation of the Supplementary Feeding Program.
