CITY RESOLUTION NO. 160-2016

RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE CONTRACT OF EMPLOYMENT SERVICES WITH SCHOOLS DIVISION OF TUGUEGARAO CITY AND MR. DOMINGO B. FURIGAY AND MR. JERALD L. MELAD

WHEREAS, the 1987 Philippine Constitution provides for the recognition and promotion of other forms of education other than formal education particularly in Article XIV, Section 2, paragraph (1) which declares that the State shall establish, maintain and support a complete, adequate and integrated system of education relevant to the needs of the people and society and paragraph (4) concisely encourages non-formal, informal and indigenous learning systems as well as self-learning, independent and out-of-school study programs particularly those that respond to community needs;

WHEREAS, the Governance Act for Basic Education otherwise known as the Republic Act 9155 stipulates the establishment of the Alternative Learning System (ALS) to provide out-of-school children, youth and adults population with basic education;

WHEREAS, there are two major programs on ALS that are being implemented by the Department of Education, through the Bureau of Alternative Learning System (BALS) which are the Basic Literacy Program and the Continuing Education Program-Accreditation and Equivalency (A&E);

WHEREAS, the Continuing Education Program-Accreditation and Equivalency (A&E), happens outside the classroom, community-based, usually conducted at community learning centers, barangay multi-purpose hall, libraries or at home, managed by ALS learning facilitators, such as mobile teachers, district ALS Coordinators, instructional managers at an agreed schedule and venue between the learners and facilitators;

WHEREAS, Mr. Domingo B. Furigay and Mr. Jerald L. Melad are Service Contractor or Instructional Manager (IM) of the DepEd Alternative Learning System Accreditation and Equivalency (ALS A&E) System;

WHEREAS, the City Government of Tuguegarao shall provide the monthly honorarium of Ten Thousand Pesos (P10,000.00) to each Instructional Manager for a service rendered for the Alternative Learning System Accreditation and Equivalency (ALS A&E) System implementation under the supervision of the City Mayor and City Schools Division Superintendent;

WHEREAS, Mr. Domingo B. Furigay and Mr. Jerald L. Melad are not entitled to other benefits accorded to regular government employees (such as PERA, COLA, Productivity, Separation Pay, and the like), however they are duly accorded with Monthly Travel Allowance of One Thousand Pesos (P1,000.00), clothing allowance of Four Thousand Pesos (P4,000.00), City Bonus, and other incentives;

WHEREAS, the Contract of Employment Services to be entered into by the Tuguegarao City Government with Schools Division of Tuguegarao City and Mr. Domingo B. Furigay and Mr. Jerald L. Melad covers the period from August 1, 2016 to December 31, 2016;

WHEREAS, the joint committees deliberately studied the contract and approving the same as they found out that the contract is in order.


