RESOLUTION AUTHORIZING THE REVERSION OF THE POSITION LOCAL LEGISLATIVE STAFF OFFICER IV (LLSO IV) UNDER THE OFFICE OF THE VICE MAYOR FROM COTERMINOUS TO CAREER POSITION

WHEREAS, the Civil Service Commission (CSC) issued Memorandum Circular No. 12, Series of 2011 prescribing the guidelines on the determination of positions in Local Government Units (LGUs) as primarily confidential;

WHEREAS, paragraph two (2) of the above-cited Civil Service Commission (CSC) Memorandum Circular No. 12, Series of 2011 provides that positions in the Offices of the Provincial Governor, Provincial Vice Governor, City/Municipal Mayor/Vice Mayor or *Sangguniang Panlalawigan/Panlungsod/Bayan* with position titles belonging to the career service, the duties of which do not require the highest degree of trust and confidence as shown in the description of duties and responsibilities but were classified as primarily confidential under MC No. 22, s. 2007, shall be **reverted to their career service classifications**;

WHEREAS, pursuant to the above-cited circular, the position of Local Legislative Staff Officer IV (LLSO IV) under the Office of the Vice Mayor is classified as career position;

WHEREAS, there is a need to revert the position of Local Legislative Staff Officer IV (LLSO IV) under the Office of the Vice Mayor from coterminous to career position to comply with Civil Service Commission (CSC) Memorandum Circular No. 12, Series of 2011.


