**CITY RESOLUTION NO. 176-2016**

**A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT AND AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE NO. 02 FOR THE STOCK PILING OF FOOD AND NON-FOOD COMMODITIES TO BE USED EXCLUSIVELY DURING CALAMITIES/DISASTERS**

**WHEREAS**, the Department of Social Welfare and Development (DSWD) through its Field Offices is mandated to provide technical and relief augmentation assistance to LGUs affected by disaster beyond its capabilities;

**WHEREAS**, among others, the provision of relief operation in times of calamities/emergencies has been devolved upon the Local Government under Republic Act 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the City Government through the City Social Welfare and Development Office (CSWDO), with its available Evacuation Center/facility based on the standard set by the DSWD Central Office for stock piling of food and non-food commodities, is willing to accommodate the pre-positioned relief goods to be used exclusively during calamities/disasters.

**NOW THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to authorize the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Social Welfare and Development (DSWD) Regional Office No. 02, represented by OIC Regional Director Ponciana P. Condoy for the stock piling of food and non-food commodities to be used exclusively during calamities/disasters.

**RESOLVED FURTHER**, that copy of this Resolution be forwarded to the City Mayor, Hon. Atty. Jefferson P. Soriano, for his information and appropriate action and to the Department of Social

Welfare and Development (DSWD) Regional Field Office No. 02, represented by OIC Regional Director Ponciana P. Condoy, for her information and reference.
