**CITY RESOLUTION NO. 177-2016**

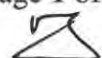
**RESOLUTION APPROVING THE RENEWAL OF THE LEGISLATIVE FRANCHISE OF THE  
 DUPAYA RECREATION CENTER, INC. TO OPERATE A COCKPIT IN  
 TUGUEGARAO CITY FOR A PERIOD OF THREE (3) YEARS**

**WHEREAS**, the Dupaya Recreation Center, Inc. with business address at Maharlika Highway, Barangay Leonarda, Tuguegarao City is a duly established corporate entity under the laws of the Republic of the Philippines;

**WHEREAS**, the Dupaya Recreation Center, Inc. has all the qualifications and none of the disqualifications to operate and maintain, for recreational and commercial purposes, a cockpit within Tuguegarao City, having complied with all the requirements of Ordinance No. 08-2005, otherwise known as the "The Cockfighting Ordinance of 2005";

**NOW THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the renewal of the Legislative Franchise of the Dupaya Recreation Center, Inc. to Operate a Cockpit in Tuguegarao City, subject, however, to strict compliance with the provisions of Ordinance No. 08-2005 and to the following conditions:

1. That the franchise shall be for a period of three (3) years from January 2016 to December 2019
2. Payment of the franchise fee
3. Compliance with the requirements under Resolution No. 005-2006 (Guidelines on the Implementation of the Cockfighting Ordinance)
4. That it shall operate on Sundays only starting 9:00 AM and shall end at 7:00 AM the following day without prejudice to the issuance of a special permit to hold derbies/pintakasis on said date and such other dates or holidays not exceeding three (3) days upon the payment of the requisite fees and charges, provided that such derby/pintakasi shall not go beyond 7:00 AM of Monday



5. That the management shall strictly comply with all the conditions and regulations provided for under Ordinance No. 08-2005, Local Revenue Code and other rules and regulations

On motion of Hon. Anthony C. Tuddao, duly seconded by Hon. Danilo L. Baccay and without any objection, **CITY RESOLUTION NO. 177-2016** was **APPROVED** in plenary under suspended rules.
